OFFICIAL RULES**

HOW TO PARTICIPATE:

1. Must be a Backstage Pass Member.
2. Must earn 100 base gaming points within your birthday month to be eligible.

4. Vouchers expire on the last day of birthday month.
5. Guests must present their valid photo I.D., Backstage Pass and voucher to redeem.
